What we do	
How does SOFCU protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files. We restrict access to nonpublic personal information about you to those employees who need access to provide products and services to you.
How does SOFCU collect my	We collect your personal information, for example when you
personal information?	 Open an account or deposit money Make loan payments or apply for a loan Use your Debit or Credit Card We also collect your personal information from others, such as credit bureaus or other companies.
Why can't I limit all sharing:	 Federal law gives you the right to limit only Sharing for affiliates' everyday business purposes – information about your creditworthiness Affiliates from using your information to market to you Sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing.
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.
